#### A. Call to Order

John Ladd called the meeting to order at 9:35 a.m.

#### B. Introductions

Introductions were made around the room.

**C. Call to the Public:** Chris Postel—Board Clerk for Santa Cruz, Winkleman, and Pima NRCDs gave a brief overview regarding what the three NRCDs are involved in that he clerks for.

## D. Review and Approval of Meeting Minutes

1. Telephonic, Regular Meeting, December 18, 2019

#### E. Agency and Committee Reports

**1. USPP:** Lucinda Earven reported the next meeting will be February 12, 2020 from 9:00 a.m.—noon in the Mona Bishop Room in the Sierra Vista Library.

2. NRCS: Don Decker reported starting the week of January 20<sup>th</sup> Dusty Glidewell will be filling in as the Acting District Conservationist for the Yuma and Parker Field Offices. The assignment could last for the next three to four months. Dusty said hopefully she will still be able to help the Douglas Field Office.

For EQIP, there's no new cost list yet and no cut-off date has been decided, so there's no schedule as to when documents are due.

The question was asked if there is any development on an NRCS archeologist. Don said, "it's a positive." NRCS is hiring private consultants. For Southern Arizona it's Paleo West. Hopefully this month archeologists will be "on the ground," beginning archeological surveys. They will be concentrating on the present backlog.

- **4. BLM:** No one present to report, however Eric Baker emailed comments concerning the existing SPRNCA allotment holders which were forwarded to Board members.
  - 5. AZGFD: No one present to report.
- **6. CCRN:** John Ladd reported the next meeting is scheduled for February. He said they were out last Monday monitoring Horseshoe Draw. Horseshoe Draw is working well, however, at the inlet smaller rocks were used than should have been used—basketball sized rip-rap is too small so there is some erosion.

They are still searching for grants for the Bella Vista Project. To date there is nothing positive about securing the money. Hans Huth is involved in helping them find funding.

- **7. SLRP:** Joy Banks attended the last meeting and reported Willie Sommers is stepping down as chairman. The next chairman will be a partnership between two gentlemen, one of which is Ryan Fitzpatrick. The next meeting is February 7, 2020, 1:00 p.m.—4:00 p.m. in the Mona Bishop Room at the Sierra Vista Library. Joy volunteered to represent HNRCD at SLRP meetings in the future. A main value of SLRP is getting the various agencies to work together.
- **8.** Arizona Department of Environmental Quality (ADEQ): Hans Huth reported on Horseshoe Draw. Hans developed and installed a new type of remote technology at Horseshoe Draw. The technology installed was a pilot project and due to some problems Hans pulled the equipment.

Samples from Greenbush Draw showed high levels of E coli but whether the E coli was human or bovine had not been determined. Hans said there has not been a sewage overflow from Naco, Sonora, Mexico since last year.

Hans felt ADEQ should be supporting the CCRN Bella Vista Project because of Sierra Vista runoff which is potentially sources for E coli. The Bella Vista Project could address this situation.

Hans was excited about the work being done by Van Clothier and his book, *Let the River Do the Work, Induced Meandering, an Evolving Method for Restoring Incised Channels.* Hans hopes to use Van Clothier's method on other properties.

HNRCD did not apply for any grants last year.

- 1. "Director" for HNRCD Education Center: Jim Lindsey reported he had spoken with Sharma Torrens—AACD regarding HNRCD's need for an official director. She felt the way the HNRCD's Education Center is set up there is no need for an official director. HNRCD's Education Center is part of the District. There is no separate EIN number for the Ed Center—it is not a separate entity. The State funds are however, kept separate, hence the reason for multiple checking accounts. Mike Hayhurst may know of a person that would be interested in volunteering for an education center director job.
- **2. Tombstone High School Ag Program:** Mike Hayhurst reported their welding program is a "go." They are going to begin welding through the advanced agriculture class. Amber Ford—THS Agriculture has a welding certification and can teach welding.
